Canfyddiadau

1. Baw Cŵn

Dyma'r prif bwnc a godwyd, sef cwynion am berchnogion cŵn sydd ddim yn glanhau ar ôl eu cŵn ar balmentydd a llwybrau'r pentref

Camau i'w cymryd / wedi'u cymryd

Mae yna flychau dal bagiau cŵn newydd wedi cael eu gosod yn y pentref ac mae bwriad i gael rhagor yn y flwyddyn ariannol nesaf.

2. Uwchraddio'r Parc

Cafwyd nifer o sylwadau am y parc a'r angen i drwsio a diweddarau'r parc.

Camau i'w cymryd / wedi'u cymryd

- Mae £1,000 wedi ei glustnodi yng nghyllideb y Cyngor Bro ar gyfer 2023/2024 ar gyfer gwella'r matiau ac adnewyddu dau swing
- Bydd y Cyngor Bro yn ymchwilio i grantiau er mwy medru datblygu'r Parc yn gyflymach
- Bydd y Cyngor Bro yn ymgynghori ar gynlluniau wrth gyflwyno ceisiadau am grantiau

3. Creu Tir Hamddena

Derbyniwyd neges glir gan garfan o'r bobl a ymatebodd i'r holiadur yn nodi yr hoffent weld tir yn cael ei gadw/ddatblygu ar gyfer hamddena

- Mae'r Cyngor Bro wedi sicrhau tir ac gyfer rhandiroedd sydd eisoes wedi cael eu gosod ac maent wedi cael eu defnyddio am y tro cyntaf y gwanwyn hwn
- Mae'r Cyngor yn teimlo'n gryf o ran cadw'r tir glas rhwng yr A55 a'r pentref yn dir na fydd yn cael ei ddatblygu; a gwrthwynebodd y Cyngor yn gryf i'r cais cynllunio i godi tai y tu ôl i Stad y Garnedd

- Mae'r Cyngor Bro eisoes wedi gofyn am gyngor gan unigolyn sy'n brofiadol yn y maes a deallir fod y gwaith hwn yn gofyn am arbenigedd a mewnbwn amser sylweddol
- Mae'r Cyngor Bro yn agored i'r syniad hwn ac am barhau i ymchwilio i bosibiliadau, ond nid oes cynllun pendant i weithredu unrhyw gynlluniau ar hyn o bryd

5. Cynnal a chadw llwybrau cyhoeddus

Cafwyd adborth fod hwn yn faes sydd angen sylw

Camau i'w cymryd / wedi'u cymryd

- Mae'r Cyngor Bro yn gyfrifol am rai llwybrau ac yn cyflogi unigolyn i'w cynnal a'u cadw yn rheolaidd. Byddwn yn adolygu'r trefniadau hynny er mwyn gwella eu cyflwr
- Mae'r Cyngor Sir yn gyfrifol am gynnal a chadw rhai llwybrau eraill. Byddwn yn codi'r mater hwn hefo nhw er mwyn gwella eu cyflwr

6. Parcio/Gor-yrru

Mae hyn yn cael ei weld fel problem mewn mwy nag un lleoliad, hefo parcio wrth yr ysgol yn cael ei nodi'n aml, a chyflwr maes parcio Pringles yn destun beirniadaeth.

Camau i'w cymryd / wedi'u cymryd

- Mae hi'n fwiad gosod peiriant talu ac arddangos ym maes parcio'r 'Post' fel nad ydy pobl yn gadael eu ceir yno drwy'r dydd
- Byddwn yn cynnal trafodaethau hefo'r Ysgol a'r Cyngor Sir am y parcio ar y brif ffordd wrth ymyl yr ysgol
- Rydym wedi trefnu bod llinellau melyn dwbl wedi cael ei peintio gyferbyn â'r Co-op a bydd lleoliadau eraill yn cael eu hystyried yn y dyfodol agos
- Mae'r cyflymder uchaf ar Ffordd Caergybi wedi cael ei ostwng i 20mya yn unol â'r rheolau cenedlaethol newydd

ACTING ON THE PEOPLE'S VIEWS 2022

Background

In Autumn 2022, a survey was conducted via Facebook with Llanfairpwll villagers, to receive their views on various issues and priorities in the village. In order to ensure credibility to the process (and the Community Council!), of having sought the views of the villagers, it is essential that we report back to them to explain what we propose to do. This paper summarises that, addressing the main issues/priorities raised.

Findings

1. Dog Fouling

This is the main topic raised, complaints about dog owners who don't clean up after their dogs on the village pavements and paths.

Steps to be taken / already taken

New dog bag boxes have been installed in the village and more are planned for next financial year.

2. Park Upgrade

There have been a number of comments about the park and the need to repair and update the park.

Steps to be taken / already taken

- £1,000 has been earmarked in the Community Council's 2023/2024 budget for mat improvements and two swing refurbishments
- The Community Council will investigate grants to develop the Park
- The Community Council will consult on plans when submitting grant applications

3. Create a Recreation Ground

A clear message was received from a cohort of people who responded to the questionnaire stating that they would like to see land retained/developed for recreation

Steps to be taken / already taken

- The Community Council has secured land and allotments have already been laid out and have been used for the first time in the spring 2023.

- The Council feels strongly about keeping the green land between the A55 and the village undeveloped; and the Council strongly objected to the planning application to build houses behind the Garnedd Estate.

4. Establish a local energy plan

Interest has been expressed in this idea

Steps to be taken / already taken

- The Community Council has already sought advice from an individual experienced in the field and it is understood that this work requires significant expertise and time
- The Community Council is open to this idea and wants to continue to explore possibilities, but there is no concrete plan to implement any plans at this time.

5. Public footpath maintenance

There has been feedback that this is an area that needs attention

Steps to be taken / already taken

- The Community Council is responsible for some routes and regularly employs an individual to maintain them. We will review those arrangements to improve their condition
- The County Council is responsible for the maintenance of some other routes. We will raise this issue with them to improve their condition

6. Parking/Speeding

This is seen as a problem in more than one location, school parking is frequently noted, and the condition of Pringles car park the subject of criticism.

Steps to be taken / taken

- It is planned to install a pay and display machine in the 'Post' car park so people don't leave their cars there all day
- We will be in discussions with the School and the County Council about the parking on the main road next to the school.
- We have arranged for double yellow lines to be painted opposite the Co-op and other venues will be considered in the near future
- Top speed on Holyhead Road has been reduced to 20mph in line with the new national rules.

7. Condition of the Station and Pringles Car Park

The Community Council is in regular contact with Pringles' management and the condition of the car park has already been raised with them and there are plans to carry out work there by the company.

8. Communication

While Facebook is one effective medium to share information about the work of the Community Council, we recognise that not everyone uses that medium. We will be looking at ways to improve our communications, and that includes finishing upgrading the website, and installing a new Information Board next to the Park (as well as the one near the Dentist's Surgery).

9. Volunteering

Thank you so much for expressing your willingness to work together with the community Council, on a voluntary basis, in a number of different ways. We will do more during the year to improve communication with village residents and to give those who want the opportunity, to contribute to different projects or activities.
